Presidential Address

13th AGM - ALUCAST 15:00 Hrs - Monday, January 09, 2023



Dear Friends,

On behalf of the Aluminum Casters' Association (ALUCAST)®, India, I extend a warm welcome to all the Trustees, Members, Participants and Invitees to this 13th AGM of Aluminum Casters' Association (ALUCAST)®, India.

As the world continues to face trying times, the die-casting industry remains no exception. As per recent reports the forecast for world economic growth has been reduced from 3.2% in 2022 to 2.7% in 2023. Various factors are attributed to this decelerating growth.

Multi-mutations of the Covid-19 virus, the global geopolitical situation and the Russia-Ukraine War have adversely impacted global business.

The energy export restrictions from Russia, the supply chain disruptions due to restrictions at major Asian ports and lockdowns in China have led to rise in cost of logistics, uncertainty in availability of containers and thereby unpredictable delivery.

As we see some respite in the availability of semi-conductors, the apprehension continues to linger. The reasons being 40% of Palladium and Nickel essential for chips comes from Russia and 70% of Neon supplies that go into chips come from Ukraine. The 5G roll out is also likely to affect the availability of the chips. In addition, global inflation is higher than seen in previous decades.

On the other hand Indian economy is steadily moving towards prosperity despite the global situation. Today, India is the 5th largest economy surpassing U.K. The economic growth is pegged at 6.9% for 2023. Key growth enablers for India being, stable government, the young population with an average age of below 30 years and is the 4th largest country in terms of FDI as a percentage of GDP.

The automobile industry, the single largest customer for die-casting industry is seeing strong signs of revival. However, this revival needs more adaptability from component manufacturers to support the emerging trend of moving towards EVs.

The Indian Aluminum Die-casting industry has always catered to the new trends and demands of its end users by adapting and absorbing rapidly changing technologies. The industry has proven to have cost advantages for global sourcing ranging from 10 to 20% when compared to some of the developed nations.

There is no denying that the aluminum die-cast industry has its own share of challenges like skilled manpower for operating die cast machines. It is my privilege to state that to address this concern ALUCAST has initiated tie-ups with colleges and is providing certification courses and hands on experience on the machines to students wishing to pursue their career in this industry.

At ALUCAST we understand to be globally competitive die-casters have to focus on production from recycled raw-materials, use of energy saving equipment, adoption of closed system to recycle and reuse as much material as possible. This is also the mandate from all environment management certification organizations.

In view of the same, the biennial Event ALUCAST 2022 Conference & Exhibition was given the theme "Green and Smart Die-Casting Solutions for Sustainability".

This event was very successful as we saw 32 paper presentations from national and international delegates, 200+ conference participants, a footfall of over 5000+ visitors, participation by 148 organizations and over 175+ brands were showcased.

It is worthy of mention that this event was held in person after a gap of 4 years and we received a very positive response from the industry.

Special thanks to Dr. Lakshmi Venu who spearheads Sundaram Clayton Foundry, for being kind enough to accept our invitation as Chief Guest and also for sharing her valuable insights on the inaugural day event.

To conclude, I take this opportunity to thank all the Trustees, Members, ALUCAST Secretariat and Office Bearers for not just a successful event but also for managing the operations seamlessly throughout the year and keeping the organization relevant to the industry.

Minutes of the Meeting

12th Annual General Meeting Aluminium Casters' Association (ALUCAST)®, India

Held at 5th January 2022 from 12.00 pm to 1.00 pm - Virtual Meeting on ZOOM - Duly Recorded

- 1. The Secretary called the Meeting to Order at 12.00 hrs. Since there was no Quorum, the Meeting was deferred for 15 minutes.
- 2. At 12.15 hrs the Secretary called the Meeting to Order again. While there was still no Quorum, as per the Rules of the Association, the Meeting commenced.
- 3. The President and Trustee, Mr. Prasan Firodia, took the chair and welcomed everyone present.
- 4. The President gave his Annual Address to all those present, briefed everyone about the ALUCAST activities carried out during the FY 2020-2021 and thanked everyone for the support rendered to ALUCAST.
- 5. Since the Minutes of the 11th AGM were part of the Annual Report, those present took the same as read and approved. Proposed by Mr. T. Parabrahman and Seconded by Mr. RAR Prasad.
- 6. The Annual Audited Accounts for FY 2020-2021 were presented by Mr. Niranjan Toraskar, Hon. Treasurer and Trustee. He explained that the loss carried forward was because 2020-2021 was not a major event year. The President intervened and explained that every alternate year ALUCAST was prone to carrying forward a loss because a major event would be missing-which normally generated sufficient revenue for two years at a time. The Accounts for FY 2020-2021 were then passed and approved. Proposed by Mr. Jitendra Lakhotia and Seconded by Mr. R.T Kulkarni.
- 7. The Secretary stated that M/s P G Bhagwat LLP have given their consent for reengagement as Auditors for FY 2021-2022. It was resolved that M/s. P G Bhagwat LLP be appointed as Auditors for ALUCAST for the FY 2021-2022 at a fee similar to FY 2020-2021

- 9. The President thanked all the Trustees, the Auditor, the Accountant and his staff, the Secretariat and all Members for their efforts in the past year and exhorted them to continue in the same vein in the next financial year.
- 10. The Secretary on behalf of everyone proposed a Vote of Thanks to the Chair and thanked the President and Trustees and all the ALUCAST Members for backing the Secretariat to the hilt in all efforts in FY 2020-2021.
- 11. There being no further business to transact, the Meeting was closed.
